OFFICIAL RULES

No purchase necessary to enter or win.

All participants in order to enter the contest must be a parent or guardian of the children creating the art.

TO ENTER: Between November 12 and **December 16, 2020 (Extended from original December 9 date)**, families with children between the ages of 4-17, can enter the contest by having their children draw their piece of art imagining their experience in a Wonderland of Food, using food drawing components to create landscapes, portraits of people or animals, winter themed and holiday season themed subjects. Contest submissions will be judged and awarded by age groups divided by ages 4-8, 9-13, 14-17. Each artist/contestant will be asked to draw their piece of art on an 8.5" x 11" or 11" X 14" sized drawing pad page (Letter or Tabloid Size). The creation of their art will be judged on how creatively and uniquely the drawings integrate food drawings or paintings to produce their art piece. The contestants will be encouraged to use their imaginations in their creation by including and incorporating drawings or paintings of various types of fruits, vegetables, nuts, meats, fish, dairy items or anything else food oriented that they can conceive of to create their art. Once completed, please bring your creations to your local NetCost Market Store on or before **December 16th, 2020 (Extended from original December 9th date)** for contest entry and display and deposit them in the specially created "Wonderland Of Food" drawing and painting contest entry boxes located in each of the stores.

Parents of participants will be asked to provide on their submissions (reverse side), their name and contact information as well as their child's name and age (at the time of submission). The collection of this information is to be used solely for the distribution of prizes to the winners. Contact information will not be stored or sold or used in any other way. In each NetCost Market location, there will be a special NetCost Market Holiday "Wonderland of Food" Art mailbox. Each child and their parent is asked to drop their art piece off at one of the mailboxes during the dates November 12-**December 16, 2020 (Extended from original December 9 date)**. All Submissions will become the property of NetCost Market. NetCost Market will display as many of the submissions as possible and will show these submissions in social media and web properties.

Limit: ONLY 1 Entry per child, families with multiple children can enter with each child between the ages of 4-17.

No Purchase Necessary to Enter or Win the Sweepstakes.

Prizes: There will be many prizes that could include gift cards, televisions, tablets and computers, games, toys, and an assortment of other prizes. Prizes will be awarded by judges who will be rewarding submissions by each of the three age group brackets. The prize ceremony will be held at NetCost Market, 3100 Ocean Avenue, Brooklyn, N.Y. 11235 on **December 20, 2020 (Changed from original December 19 date) at 1 p.m.** All area participants are asked to be present during the awarding of prizes. Those who cannot make the award ceremony and who do win a prize will be contacted at a date after **December 20, 2020 (Changed from original December 19 date)**. Brooklyn area Prize winners will be asked to pick up their prizes from the 3100 Ocean Avenue, Brooklyn, N.Y. location from January 2nd through January 15th, 2021. Participant winners from other NetCost Market store locations in Queens, Staten Island, NJ and PA, will have their prizes sent to the respective store of entry for pick up from January 2nd through January 15th, 2021.

PRIZE CEREMONY: The awarding of prizes will be in each age category. Art pieces will be collected from all of the participating NetCost Market retail locations on **December 16th, 2020 (Extended from original December 9th date)**. The Art Pieces will be judged on the creativity, originality, imaginative use of food and picked out of the collection to win. The ceremony will take place at 1 p.m. at NetCost Market, 3100 Ocean Avenue, Brooklyn, N.Y. 11235. Depending on any legal or health restrictions based on Covid 19, All local Brooklyn participants will be encouraged to be present for the drawing at **1 p.m. on December 20th, 2020 (Changed from original December 19th date)** at 3100 Ocean Avenue, Brooklyn, N.Y. 11235, winners chosen who are not present at the time of the drawing will be contacted at a date after **December 20 (Changed from original December 19 date)** and awarded the prizes. All prizes must be picked up at the store location in Brooklyn. Out of area prize winners will have their prizes sent to their respective local NetCost Market store for pick up.
